<b>Permit(s) obtained for the Competition</b>	N/A – major prize under \$10,000
<b>Participating Retailers</b>	N/A
<b>Entry – residency restriction</b>	Giveaway is only available to residents who dine at Kellyville Grove on 12 May 2024.
<b>Entry – age restriction</b>	Gifts are only available to persons over 13 years of age
<b>Competition Period</b>	From 9am AEST Sunday 12 May, whilst stocks last.
<b>How to be eligible</b>	To receive a free rose, customers must (a) Dine-in at either Gilly's Café, Second Home Café or XS Espresso Kellyville Grove (b) Limited to first 20 tables at each Café
<b>Are multiple gifts permitted?</b>	No, one rose per table.
<b>Gift(s) – description</b>	Hermosa single stems, petals reflexed, wrapped and tied with ribbon.
<b>Total number of Prizes</b>	There are 60 individually wrapped roses, 20 allocated per café.
